RULES AND REGULATIONS GOVERNING PARTICIPATION IN DESI PLAY TV PRESENTS BIGG BOSS CONTEST – THE #WEEKLYBIGGBOSSBONANZA ("RULES")

A. BRIEF DESCRIPTION OF CONTEST:

Desi Play TV presents Bigg Boss Contest – The #WeeklyBiggBossBonanza is a multiple-choice question-answer based contest ("Contest") about the Bigg Boss-16 reality television programme ("Show") aired on Colors Channel (USA Feed) ("Channel") organized during the Term (set out below).

The Contest will be conducted in English language as set out on Channel's website bearing URL: www.aapkacolors.com/biggbossusa ("Website") that is hosted by IndiaCast Media Distribution Private Limited ("IndiaCast"). For the purposes of these Rules, "Organisers" will mean IndiaCast and Viacom18 Media Private Limited ("Viacom18").

Any participation in the Contest is governed by these Rules. Any individuals who participate in the Contest by providing answer to question on the Website ("Applicant" or "Participant/s") agrees to comply with these Rules.

B. CONTEST AND PARTICIPATION DETAILS:

1. <u>Contest Details:</u>

Contest shall be organised on a weekly basis from ET 9 P.M. / PT 10 P.M. on January 9, 2023 and shall tentatively continue till ET 10:30 P.M. / PT 11:30 P.M on February 5, 2023 ("**Term**") as detailed in the table hereinbelow. The Organisers will select a total of 5(five) winner(s) of the Contest during the Term (in the manner as detailed in the below mentioned table under para number 7.1.) of the Contest each week. ("**Winner(s)**").

The Term is subject to change/modification without prior notice, at the sole discretion of the Organisers.

2. **Participation Mechanism:**

The Participant will be required to visit (a)URL: www.aapkacolors.com/biggbossusa ("Website") (b) Participant needs to fill in their details such as: (i) name (ii) current valid email address (iii) Country of Residence (iv) City, (v) Confirmation of Age above 18 years (Yes/No), (c) Answer 2 (two) questions every week during the show ET 9 P.M. / PT 10 P.M. to ET 10:30 P.M. / PT 11:30 P.M. by selecting the correct answer from 2 (two) options provided for each question, (d) Accept the Terms & Conditions, Privacy Policy provided on the Website, and (e)give consent to collect, use, and store the aforementioned details.

The Participant(s) shall not have the right to submit multiple entry(ies) for the Contest.

C. GENERAL RULES FOR PARTICIPATION IN THE CONTEST:

- 1. The Contest is open only to legal residents of the United States of America having attained 18 years of age.
- 2. Participation in the Contest is purely voluntary, and no registration fee is charged to the Participant in any

- manner whatsoever by the Organisers or any other person associated with the Contest.
- 3. The entry through the Participation Mechanism shall be deemed to have been casted only when such entry reaches Organiser's internet/network provider's server. Any unclear/incorrect/incomplete entry, including wrong characters or absence of valid user id, shall be considered invalid entry, and deemed null and void.

7.2. The announcement of the Winner(s) will be made on a weekly basis on the respective date of Winner(s) announcement (detailed in table hereinabove) via On-Air Aston and social media post on the official social media accounts of Aapka Colors viz., _____, ____. Each Winner of the Contest shall win 1(One) gift voucher worth USD 500/- (United States Dollars Five Hundred only) ("Prize/Gratification"). The Winner(s) permits the Organisers to contact and notify him/her personally on the email address provided

by the Participant(s)/Winner(s), vide the Organiser e-mail id: marketing.uk@indiacast.com. The Winner(s) shall claim the prize within 48 hours from the date of announcement/notification from the Organiser. If the Winner(s) fails to claim the prize/gratification within 48 hours, then such Winner(s) would be considered to have forfeited their claim on their Prize, and a new winner shall be selected by the Organiser from the submitted correct entries of Participants. 23. <u>Limitation of Liability:</u>

- 23.1. The Participant categorically agrees that subject to limitation of liability, in the event any damage or imminent damage to the Participant (if any) is estimable, then damages shall be adequate relief in law. Accordingly, the Participant also agrees that it shall not be entitled to any (temporary or perpetual) injunctive relief (including preventive injunction) against the Organisers, even in the event of any breach (actual or threatened) by the Organisers.
- 23.2. To the extent permitted by law, the Organisers shall not be liable to the Participant in contract, tort or otherwise, whatever the cause thereof, for any loss of use, data, profit, business or goodwill or any indirect, special, consequential, incidental or punitive cost, damages or expense of any kind, howsoever arising under or in connection with the Contest. 24. Governing Law and Dispute Resolution:

- 24.1. <u>Governing Law</u>: These rules and regulations and Contest shall be governed by and construed in accordance with laws of India and subject to sub-section (b) below, the Participant submits irrevocably to the jurisdiction of the courts in Mumbai only.
- 24.2. <u>Arbitration</u>: If any dispute arises between the Participant and the Organisers hereto, in connection to any aspect of the Contest ("**Dispute**"), either party may give forty-five (45) days' notice of invocation of the arbitration provisions contained herein ("**Arbitration Notice**"), to the other party in writing.

The arbitral proceedings shall be governed by (Indian) Arbitration and Conciliation Act, 1996 as amended from time to time and the Parties hereby agree to resolve their Dispute(s) by an arbitral tribunal consisting of a single arbitrator. In the event the Parties are unable to mutually agree upon a single arbitrator within thirty (30) days from the Arbitration Notice, either party may approach the competent court who shall

appoint such single arbitrator. The venue of the arbitration shall be Mumbai (India). The proceedings of arbitration shall be in English language.

The costs of arbitration proceedings shall be borne equally by the parties during the arbitral proceedings. However, the court or the arbitral tribunal (as the case maybe) shall have the discretion to determine as part of the award or the final order terminating the arbitral proceedings as to which party will pay the costs thereof.
